SECTION 1. 174.02 (1) (b) of the statutes is amended to read:

174.02 (1) (b) *After notice.* Subject to s. 895.045 and except as provided in s.

895.57 (4), the owner of a dog is liable for 2 times the full amount of damages caused

by a bite resulting in bodily harm to a person if the owner was notified or

knew that the dog had previously bitten a person resulting in bodily harm.
