22	(5) "Conservator" means a person appointed under s. 54.76 to manage the
23	estate of a living individual.
24	(6) "Content of an electronic communication" means information concerning
25	the substance or meaning of a communication that satisfies all of the following:

1	(a) The information was sent or received by a user.
2	(b) The information is electronically stored by a custodian that provides an
3	electronic communication service to the public or is carried or maintained by a
4	custodian that provides a remote computing service to the public.
5	(c) The information is not readily accessible to the public.
6	(7) "Court" means the circuit court having jurisdiction over a matter related
7	to this chapter.
8	(8) "Custodian" means a person that carries, maintains, processes, receives, or
9	stores a user's digital property.
10	(9) "Designated recipient" means a person chosen by the user using an online
11	tool to administer the user's digital property.
12	(10) "Digital property" means an electronic record in which a person has a right
13	or interest. "Digital property" does not include underlying property or an underlying
14	liability unless the property or liability is itself an electronic record.
15	(11) "Electronic" means relating to technology having electrical, digital,
16	magnetic, wireless, optical, electromagnetic, or similar capabilities.
17	(12) "Electronic communication" has the meaning given in 18 USC 2510 (12).
18	(13) "Electronic communication service" means a custodian that provides to a
19	user the ability to send or receive an electronic communication.
20	(14) "Fiduciary" means an original, additional, or successor personal
21	representative, conservator, guardian, agent, or trustee.
22	(15) "Governing instrument" has the meaning given in s. 854.01 (2).
23	(16) "Guardian" means a person appointed under s. 54.10.
24	(17) "Information" means data, text, images, videos, sounds, codes, computer

(29) "Will" includes a codicil and any document incorporated by reference in a 6 testamentary document under s. 853.32 (1) or (2).

711.04 Priorities; user directions for disclosure of digital property. (1) 8 A user may use an online tool to direct the custodian to disclose to a designated 9 recipient or not to disclose some or all of the user's digital property, including the 10 content of electronic communications. If the online tool allows the user to modify or 11 delete a direction at all times, a direction regarding disclosure using an online tool 12overrides a contrary direction by the user in a will, trust, power of attorney, or any 13 other governing instrument.

14(2) If a user has not used an online tool to give direction under sub. (1), or if the 15custodian has not provided an online tool, the user may allow or prohibit disclosure 16 to a fiduciary of some or all of the user's digital property, including the content of 17electronic communications sent or received by the user, in a will, trust, power of 18 attorney, or any other governing instrument.

19 (3) A user's direction under sub. (1) or (2) overrides a contrary provision in a 20 terms of service agreement that does not require the user to act affirmatively and 21distinctly from the user's assent to the terms of service.
