1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 1: before that line insert:

3 **“SECTION 1d.** 5.02 (6m) (f) of the statutes is amended to read:

4 5.02 **(6m)** (f) An unexpired identification card issued by a university or college
5 in this state that is accredited, as defined in s. 39.30 (1) (d), that contains the date
6 of issuance and signature of the individual to whom it is issued ~~and that contains an~~
7 ~~expiration date indicating that the card expires no later than 2 years after the date~~
8 ~~of issuance~~ if the individual establishes that he or she is enrolled as a student at the
9 university or college on the date that the card is presented.”.
