Assumptions Used in Arriving at Fiscal Estimate

The bill requires Milwaukee County to enter into an agreement with the Department of Revenue (DOR) to collect certified debt owed to the county.

DOR estimates that it will require 7.0 FTE positions to provide debt collection for Milwaukee County. DOR expects to incur costs of \$222,000 in fiscal year 2016 and \$649,000 annually beginning in fiscal year 2017 related to personnel, supplies, and services.

SDC is a self-funded program, and the SDC collection fee will be sufficient to fund related personnel, supplies, and services expenses. However, the bill as currently drafted does not provide DOR with the position authority to hire additional staff necessary to fully and most efficiently collect Milwaukee County's delinquent debt.
