It is my intention to resign the position of State Senator once the State's 2015-2015 Biennial Budget has been passed and signed into law. With that stated goal, I will fulfill my obligation to my senate district constituents to represent them with a vote on the most important piece of legislation that will be taken up during this session.

Knowing that the intent of the legislature is to complete discussion on, and subsequently pass, the biennial budget in June, and after much consideration, I will be stepping down from the Wisconsin State Senate on July 17, 2015. By expressing my resignation this early my hope is that the Governor will be able to set a Special Election date that will allow the voters to choose my successor and provide little time without a Senator representing the 33rd district.
