Call to Order and Roll Call

Co-Chair Brooks called the meeting to order. The roll was called and it was noted that a quorum was present. Co-Chair Brooks reminded members that bills recommended today will be considered for introduction into the Legislature by the Joint Legislative Council.

Approval of the Minutes of the Committee's February 1, 2017 Meeting

Co-Chair Brooks asked for a motion to approve the committee's February 1, 2017 minutes.

Committee Report of the Study Committee on Publication of Government Documents and Legal Notices

Representative John Spiros, Chair, Study Committee on Publication of Government Documents and Legal Notices, accompanied by Steve McCarthy and Scott Grosz, Legislative Council staff, presented the report of the Study Committee. Representative Spiros gave a brief description of the committee's work and the two recommendations before the Council.

Committee Report of the Study Committee on the Preservation of Burial Sites

Representative Amy Loudbeck, Chair, Study Committee on the Preservation of Burial Sites, accompanied by Anna Henning and Amber Otis, Legislative Council staff, described the course of the Study Committee's work and outlined the committee's recommendation.

After discussion and questions from committee members, Co-Chair Brooks asked for a motion to introduce LRB-0821/1:

Committee Report of the Study Committee on Access to Civil Legal Services

Representative Cody Horlacher, Chair, Study Committee on Access to Civil Legal Services, accompanied by David Moore and Rachel Snyder, Legislative Council staff, gave a summary of the Study Committee's meetings and described each of the committee's three recommendations.

After committee discussion, Co-Chair Brooks asked for a motion to introduce the following recommendations *en masse* of the Study Committee on Access to Civil Legal Services:

Committee Report of the Special Committee on State-Tribal Relations

Representative Jeff Mursau, Chair, Special Committee on State-Tribal Relations, accompanied by David Moore and Jessica Ozalp, Legislative Council staff, gave a summary of the committee's work and described the three recommendations of the Special Committee.

Co-Chair Brooks asked for any questions from committee members. After a brief discussion, Co-Chair Brooks asked for a motion to introduce the Special Committee's recommendations *en masse*.

Roth, Darling, Fitzgerald, Marklein, Miller, Moulton, Petrowski, Risser, Shilling, Taylor, and Wanggaard); Noes, 0; and Excused, 1 (Rep. Ballweg).*
