**ASSEMBLY AMENDMENT 4,
TO ASSEMBLY BILL 748**

February 22, 2018 - Offered by Representative HUTTON.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 22: after that line insert:

3 “**(5)** APPLICABILITY. Subsections (2) and (3) do not apply to any of the following:

4 (a) An agreement with a business that operates in an electronics and
5 information technology manufacturing zone designated under s. 238.396 (1m), to the
6 extent of the business’s operations within the zone.

7 (b) An organization or local governmental unit that operates job training or
8 apprenticeship programs, to the extent that the programs prepare individuals for
9 jobs with a business described in par. (a).”

10 **2.** Page 4, line 18: delete “par. (c)” and substitute “pars. (c) and (d)”.

11 **3.** Page 4, line 21: delete “par. (c)” and substitute “pars. (c) and (d)”.

12 **4.** Page 5, line 5: after that line insert:

1 “(d) Nothing in this subsection applies with respect to or interferes with any
2 of the following:

3 1. An agreement with a business that operates in an electronics and
4 information technology manufacturing zone designated under s. 238.396 (1m), to the
5 extent of the business’s operations within the zone.

6 2. An organization or a city, village, town, or county that operates job training
7 or apprenticeship programs, to the extent that the programs prepare individuals for
8 jobs with a business described in subd. 1.”.

9 **5.** Page 5, line 23: after “103.11 (2) (d)” insert “and subject to par. (c)”.

10 **6.** Page 6, line 3: after “103.11 (2) (d)” insert “and subject to par. (c)”.

11 **7.** Page 6, line 7: after that line insert:

12 “(c) Nothing in this subsection applies with respect to or interferes with any of
13 the following:

14 1. An agreement with a business that operates in an electronics and
15 information technology manufacturing zone designated under s. 238.396 (1m), to the
16 extent of the business’s operations within the zone.

17 2. An organization or a city, village, town, or county that operates job training
18 or apprenticeship programs, to the extent that the programs prepare individuals for
19 jobs with a business described in subd. 1.”.

20 **8.** Page 6, line 20: delete “No” and substitute “Subject to par. (c), no”.

21 **9.** Page 6, line 23: delete “If” and substitute “Subject to par. (c), if”.

22 **10.** Page 7, line 2: after that line insert:

23 “(c) Nothing in this subsection applies with respect to or interferes with any of
