Assumptions Used in Arriving at Fiscal Estimate

The IT changes needed to update DMV systems to include the statutes listed in this bill, as requiring a Failure to Yield Right-of-way course, would cost approximately \$27,200.

In 2016 there were approximately 15,600 convictions for the sixteen violations specified in this bill. Assuming only approximately 33% of the individuals convicted of one of these violations contact DMV, and no more than 20% of the convictions require corrections, there will be an increase of approximately 0.63 FTE (\$35,700)

The increased scope of violations would increase the number of letters DMV would send out by approximately 25,000 which would increase postage costs by approximately \$12,200 per year.

Many of the suspended drivers will re-instate their licenses upon payment of reinstatement fee (\$60). The reinstatement fee exceeds reinstatement costs, resulting in net revenue to the department for the reinstatement. This net revenue is deposited into the transportation fund but is not appropriated for use by the department.

Long-Range Fiscal Implications

Ongoing costs, listed above, would be approximately 0.63 FTE (\$35,700) and \$12,200 in mailing costs.

Ongoing increased revenue would be approximately \$93,400 from driver license reinstatement fee collections.
