Assumptions Used in Arriving at Fiscal Estimate

- 1. Repeal of unauthorized rules. The bill eliminates some of the steps ordinarily required for promulgation of a rule, and some of the required analyses. The department of transportation ("DOT") assumes this process could reduce the cost to effect rule changes for which a change or repeal of law has eliminated DOT authority to promulgate.
- 2. Review of rules and enactments.
- A. Review of existing rules. The bill requires DOT to review its rules every 2 years and report to the legislature on rules that meet certain conditions. DOT currently has 135 chapters of code. Assuming that review of each chapter to determine whether any of the conditions apply and reporting of the findings requires 10 hours each, this will require 1,350 hours of work biennially, or 0.32 FTE annually. DOT assumes this work requirement will remain more or less constant.

Assuming 5% of its rule chapters meet the conditions that require petition for repeal, the review could require petition for repeal of as many as 6 rules each biennia. DOT estimates 200 hours for each simple rulemaking, and somewhat less time for each petition for repeal of each unauthorized rule, so petitions could require as much as 1,200 hours each biennia, or 0.29 FTE annually. DOT assumes this work requirement will decrease somewhat over successive biennia.

B. Review of acts. The legislature has averaged 366 acts during each of the past 4 biennia. Assuming that many of the acts clearly have no effect on DOT authority and will require little review and that some few acts will require extensive review, DOT assumes the required review will take 1 hour for each act. This will require 366 hours every biennia, or 0.09 FTE annually.

Assuming that 5% of the acts affect existing rules in one of the five specified ways, 18 acts biennially might require DOT action to commence rulemaking or petition for repeal. DOT estimates 200 hours for each simple rulemaking, and somewhat less time for each petition for repeal of each unauthorized rule. Assuming 18 acts require 200 hours each to complete rulemaking or repeal of unauthorized rules, the bill will require 3,600 hours of rulemaking work biennially, or 0.87 FTE annually.

DOT assumes the analyses required to review existing rules and acts to determine whether any of the 5 conditions apply will require the work of an attorney or similarly highly-skilled analyst. Attorney pay range is \$24.15-\$46.25 per hour; the estimated annual cost of the review of acts and rules is \$20,595-\$39,450 annually. Wherever rulemaking or a petition for repeal is required, DOT anticipates that work would be done by employees in a variety of pay classifications.

3. Retrospective economic impact analysis. The right to request this review is permissive and DOT cannot know for how many rules the Joint Committee for Review of Administrative Rules might direct an analysis, and whether that review might encompass an entire rule chapter or smaller subunits. In general, for ordinary promulgation of an administrative rule DOT assumes that the required identification of affected parties, consultation and coordination, together with the preparation of an economic impact analysis will require 40 hours for each subject.

Long-Range Fiscal Implications

This bill will require 1.57 FTE annually.
