# 2017 ASSEMBLY BILL 255

April 14, 2017 - Introduced by Representatives ZIMMERMAN, QUINN, E. BROOKS, TRANEL, BALLWEG, BERNIER, EDMING, KITCHENS, KRUG, KULP, MURSAU, NERISON, NOVAK, PETRYK, RIPP, SNYDER, SPIROS, SUMMERFIELD, SWEARINGEN, TAUCHEN, TUSLER, VANDERMEER, BILLINGS, DOYLE, GENRICH and MEYERS, cosponsored by Senators TESTIN, HARSDORF, BEWLEY, COWLES, ERPENBACH, OLSEN, RINGHAND and SHILLING. Referred to Committee on Rural Development and Mining.

1 AN ACT to create 20.435 (1) (fL) and 146.617 of the statutes; relating to: grants

for quality improvement initiatives and making an appropriation.

#### Analysis by the Legislative Reference Bureau

This bill requires the Department of Health Services to distribute \$100,000 in grant moneys each fiscal year to the Wisconsin Hospital Association Foundation Quality Improvement Fund to 1) increase participation by rural hospitals in quality improvement activities by the association; or 2) broaden the scope of quality improvement activities provided by the association. The bill also requires the association to submit an annual report regarding the outcomes resulting from activities funded by the grant program.
