1. Page 4, line 11. Delete lines 11 and 12 and substitute:

“the following services that are Medicare covered services under 42 USC 1395 et seq:
a. Telehealth services under 42 U.S.C. 1395m(m)4.F..
b. Remote physiologic monitoring.
c. Remote evaluation of pre-recorded patient information.
d. Brief communication technology-based services
e. Care management services delivered via telehealth.
f. Any other telehealth or communication technology-based services that are Medicare covered services.”

2. Page 5, line 2: After that line, insert:

“This paragraph does not prohibit the department from providing additional reimbursement for telehealth-related covered services under the Medical Assistance program to incentivize the delivery of covered services through interactive telehealth.”

3. Page 6, line 19: delete that line and substitute:

“under s. 227.24 as necessary to meet the effective date of coverage and reimbursement requirements specified in Section 8 of this act or s. 49.45(61)(e)(4). Notwithstanding s. 227.24 (1) (a), (2)(a)1., and (3), the department of health”

4. Page 6, line 23: delete the material beginning with that line and ending with page 7, line 4 and substitute:

“rule promulgated under this subsection. If the department publishes a scope statement for an emergency rule under this subsection, the department shall simultaneously publish a scope statement for a permanent rule. Notwithstanding s. 227.24(1)(c), an emergency rule promulgated under this act may remain in effect for 365 days, except as provided in s. 227.24(2) as modified by this act. Notwithstanding s. 227.24(2)(a), the effective period of an emergency rule promulgated under this subsection may be extended by the joint committee for review of administrative rules for a period not to exceed 180 days and any number of extensions may be granted under s. 227.24(2)(a) up to a total period not to exceed the expiration of the rule’s scope statement under s.227.135(5).”
