(b) 13 2. are (filled with) individuals who are initially admitted under an emergency 14 detention under s. 51.15. 15 2. Enters into a contract with, at minimum, two-thirds of the counties specified in par. (b) 2. in which the hospital agrees to do all of the following: 16 17 a. Be the primary receiver for individuals under an emergency detention under 18 s. 51.15 for the county. 19 b. Accept for admission under an emergency detention individuals regardless 20 of payment source. 21 c. Accept any individual subject to an emergency detention from the county 22unless all psychiatric beds added under par. (b) 2. are filled. The hospital may set

its payment rate based on the acuity of the individual being detained.

- d. Ensure the county department is the secondary payer after any other coverage the individual has is exhausted.".
