For the amendment to the Animal-Drawn Vehicle bill, SB 558, (a1000/P2) can we add that an ordinance under this subsection doesn't apply to "implements of husbandry" in addition to recreational purposes. David Moore suggested pulling the definition from 340.01(24)(a)1.

We want to be explicit that we aren't capturing the towing of farm implements.

An ordinance under this subsection may not require the registration of an animal-drawn vehicle that is used solely for recreational purposes, including use in a parade, or that is an implement of husbandry.

Something to this effect.
