The attorney working in the Guardianship Support Center suggested the following amendment options for AB 786/SB 734 to address the DCF concerns related to minor guardianships.

Insert page five, after line 13, create (e) to read "A guardian for a minor under s. 54.10(1) is exempt from pars. (a) and (b)."

Alternative, if they would prefer to use the full formal language of 54.10:

Insert page five, after line 13, create (e) to read "A guardian for the person or a guardian of the estate, or both, for a minor under s. 54.10(1) is exempt from pars. (a) and (b)."
