SUBJECT: Technical Memorandum on 2019 Senate Bill 13, relating to: notification of changed property tax assessment for agricultural land.

The department has the following concern with the bill. There are many scenarios where parcels will have mixed classes of property, such as agricultural land, undeveloped land, and agricultural forest. The department suggest the bill account for these scenarios with the following change:

However, the assessor is not required to provide notice under this section if land is classified as agricultural land, as defined in s. 70.32 (2) (c) 1g., for the current year and previous year and the difference between the assessments is \$300 or less and the assessments of other property classes on the same parcel are \$300 or less from the previous year.
