**ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 251**

June 7, 2019 - Offered by Representative RODRIGUEZ.

1 **AN ACT to repeal** 77.51 (13b); **to renumber and amend** 73.03 (71) (a), 73.03 (71)
2 (b), 73.03 (71) (c) and 73.03 (71) (d); **to amend** 66.0615 (1m) (f) 2., 77.51 (11d),
3 77.51 (13) (intro.), 77.51 (13) (a), 77.51 (13) (c), 77.982 (2), 77.991 (2) and
4 77.9951 (2); and **to create** 66.0615 (1m) (g), 73.03 (71) (a) 2., 73.03 (71) (b) 2.,
5 73.03 (71) (c) 2., 73.03 (71) (d) 2., 77.51 (7i), 77.51 (7j), 77.51 (13) (p) 7., 77.51
6 (13) (q), 77.51 (14) (n) 7., 77.51 (17) (g), 77.52 (3m), 77.52 (14) (c), 77.523, 77.585
7 (1g) and 77.585 (11) of the statutes; **relating to:** requiring marketplace
8 providers to collect and remit sales tax from third parties and reducing
9 individual income tax rates based on the collection of sales and use tax from
10 out-of-state retailers and marketplace providers.

Analysis by the Legislative Reference Bureau

Current law requires the Department of Revenue to determine the amount of additional revenue collected from the state sales and use tax from October 1, 2018, to September 30, 2019, as a result of the U.S. Supreme Court decision that expands

the state’s authority to collect such taxes from out-of-state retailers. See, *South Dakota v. Wayfair, Inc.*, 585 U.S. ___ (2018). After DOR makes that determination, the Department of Administration, in consultation with DOR, must then determine how much the individual income tax rates may be reduced for the 2019 taxable year in order to decrease individual income tax revenue by the amount of additional sales and use tax revenue. If a review by the Legislative Audit Bureau results in a redetermination of the rates, the Joint Committee on Finance decides which rates to apply. The reduction in rates only applies to 2019.

This bill makes the rate reduction determined for 2019 applicable only to the second individual tax rate listed in each bracket. Those reduced rates would change again in 2020. The bill requires DOR to estimate the amount of additional revenue collected from the sales and use tax from October 1, 2019, to September 30, 2020, as a result of the Supreme Court decision. DOA, in consultation with DOR, would then use that estimation to determine how much the second individual income tax rate listed in each tax bracket may be reduced in the 2020 taxable year. Those reduced rates would apply in 2020 and in each year thereafter. The bill also requires DOR to make its estimation of additional sales and use tax revenue based on the sales and use taxes collected from out-of-state retailers and marketplace providers.

The bill requires, generally, that marketplace providers collect and remit sales tax on sales facilitated on behalf of marketplace sellers. For purposes of the bill, a “marketplace provider” is a person who facilitates a retail sale by a seller by listing or advertising for sale, in any manner, the seller’s products or taxable services and through agreements or arrangements with third parties, directly or indirectly, who are collecting payment from the purchaser and transmitting that payment to the seller. The bill defines “marketplace seller” to mean a seller who sells products through a physical or electronic marketplace operated by a marketplace provider, regardless of whether the seller is required to be registered with DOR.

6 services or product listings and who neither collects payment from the purchaser nor
7 remits such payment to the marketplace seller.

2 77.52 **(3m)** (a) Except as provided in par. (b), a marketplace provider is liable
3 for the tax imposed under this section on the entire sales price charged to the
4 purchaser, including any amount charged by the marketplace provider for
5 facilitating the sale, from the sale, license, lease or rental of tangible personal
6 property, or items, property, or goods under sub. (1) (b), (c), or (d), or services under
7 sub. (2).

8 (b) A marketplace provider whose only activities are facilitating sales of
9 tangible personal property or services described in sub. (2) (a) 1. on behalf of
10 marketplace sellers operating under a hotel, motel, or restaurant brand name shared
11 with the marketplace provider may submit an application to the department to
12 request a waiver from collecting and remitting tax on sales facilitated on behalf of
13 marketplace sellers. The application shall include the name and address of all
14 marketplace sellers selling or furnishing such tangible personal property or services
15 in this state, the marketplace seller's sales or use tax permit number obtained under
16 sub. (7) or 77.53 (9), and any other information the department requires. The
17 department may grant the waiver if it is satisfied that the tax due under this chapter
18 is collected and remitted by the marketplace sellers. A marketplace provider that
19 is granted the waiver must, within 60 days from a written request by the department,
20 provide the name and address of all marketplace sellers selling or furnishing such
21 tangible personal property or services in this state, the marketplace seller's sales or
22 use tax permit number obtained under sub. (7) or 77.53 (9), and any other
23 information the department requires.

24 (c) The department may grant waivers under par. (b) for other types of
25 marketplace providers if there is evidence that the marketplace sellers have a

1 history of reliably collecting and remitting to the department the tax on sales or there
2 is other evidence that the marketplace sellers will reliably collect and remit to the
3 department the tax on sales.

16 and held liable for tax on the sale, unless the marketplace seller provided insufficient
17 or incorrect information to the marketplace provider under sub. (4). If notification
18 is not provided, the marketplace provider and marketplace seller may be audited and
19 held liable for tax on the sale.

20 **(3)** Upon examination by the department, a marketplace provider is relieved
21 of liability under this subchapter for the failure to collect and remit tax on a sale if
22 the marketplace provider can show all of the following to the department's
23 satisfaction:

24 (a) The sale was made solely on behalf of a marketplace seller.

25 (b) The marketplace provider notified the marketplace seller under sub. (2).

1 (c) The retail sale was properly sourced to this state under s. 77.522.

2 (4) A marketplace provider is relieved of liability under this section for failure
3 to collect and remit the correct amount of tax to the extent that the marketplace
4 provider demonstrates to the satisfaction of the department that the error is due to
5 insufficient or incorrect information given to the marketplace provider by the
6 marketplace seller, except that this subsection does not apply if the marketplace
7 provider and the marketplace seller are related entities, as defined in s. 71.01 (9am).
8 A marketplace seller that provides insufficient or incorrect information to the
9 marketplace provider may be audited and held liable for the tax if the marketplace
10 provider is relieved of liability under this subsection.

11 (6) Nothing in this section affects the obligations of a purchaser to remit use
12 tax on a transaction for which the retailer or marketplace provider and marketplace
13 seller did not collect and remit the tax.

2 quarter that is at least 3 months after publication.
