The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 36.11 (55) of the statutes is repealed.
SECTION 2. 946.13 (12) (a) of the statutes is renumbered 946.13 (12) (a) (intro.)
and amended to read:
946.13 (12) (a) (intro.) In this subsection, "research:
1. "Research company" means an entity engaged in commercial or nonprofit
activity that is related to research conducted by an employee or officer of the
University of Wisconsin System system or to a product of such research.

10	evaluated and addressed in a management plan issued by the individual or body
11	responsible for evaluating and managing potential conflicts of interest and the
12	management plan complies with the policy adopted under par. (d).
13	SECTION 5. 946.13 (12) (b) 2. of the statutes is repealed.
14	SECTION 6. 946.13 (12) (c) of the statutes is repealed.
15	SECTION 6m. 946.13 (12) (d) of the statutes is created to read:
16	946.13 (12) (d) The board shall adopt a policy specifying the contents required
17	for a management plan under par. (b).
18	SECTION 7. Initial applicability.
19	(1) This act first applies to contracts entered into, or extended, modified, or
20	renewed, on the effective date of this subsection.
