**ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY BILL 193**

May 16, 2019 - Offered by Representative GUNDRUM.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 5, line 19: delete lines 19 and 20 and substitute “administrator’s  
3 budget and comparative figures together with a statement of the county’s bonded  
4 indebtedness, in the 2 daily newspapers having the largest”.

5 **2.** Page 17, line 7: delete lines 7 to 17 and substitute:

6 “**SECTION 48e.** 65.90 (2) of the statutes is renumbered 65.90 (2) (a) and amended  
7 to read:

8 65.90 (2) (a) ~~Such~~ An annual budget shall list all existing indebtedness and all  
9 anticipated revenue from all sources during the ensuing year and shall likewise list  
10 all proposed appropriations for each department, activity and reserve account  
11 during the said ensuing year. Such budget shall also show actual revenues and  
12 expenditures for the preceding year, actual revenues and expenditures for not less  
13 than the first 6 months of the current year and estimated revenues and expenditures

1 for the balance of the current year. Such budget shall also show for informational  
2 purposes by fund all anticipated unexpended or unappropriated balances, and  
3 surpluses.

4 **SECTION 48g.** 65.90 (2) (b) of the statutes is created to read:

5 65.90 (2) (b) A biennial budget shall list all existing indebtedness and all  
6 anticipated revenue from all sources during the ensuing budget period and shall  
7 likewise list all proposed appropriations for each department, activity and reserve  
8 account during that period. A biennial budget shall also show actual revenues and  
9 expenditures for the preceding budget period, actual revenues and expenditures for  
10 not less than the first 18 months of the current budget period and estimated revenues  
11 and expenditures for the balance of the period to which the budget applies. Such  
12 budget shall also show for informational purposes by fund all anticipated  
13 unexpended or unappropriated balances, and surpluses.”.

14 **3.** Page 19, line 6: delete lines 6 to 10 and substitute “membership  
15 members-elect of the governing body of the municipality. Any municipality, except  
16 a town, which makes changes under this paragraph shall publish either a class 1  
17 notice ~~thereof of the changes~~, under ch. 985, within 15 days after any change is made  
18 or post a notice of the changes on the municipality’s website within 15 days after any  
19 change is made. Failure to give notice shall preclude any changes in the proposed  
20 budget and alterations thereto made under sub. (4). In this subsection,  
21 “members-elect” has the”.

1           **4.** Page 19, line 21: delete lines 21 and 22 and substitute “budget. The  
2       publication provisions of par. (a) shall apply to all committee transfers from the  
3       contingent fund.”.
