Analysis by the Legislative Reference Bureau

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** 48.02 (13) of the statutes is amended to read:

4 48.02 (13) "Parent" means a biological parent, a husband who has consented
5 to the artificial insemination of his wife under s. 891.40, or a parent by adoption. If
6 the child is a nonmarital child who is not adopted or whose parents do not
7 subsequently intermarry under s. 767.803, "parent" includes a person conclusively
8 determined from genetic test results to be the father under s. 767.804 or a person
9 acknowledged under s. 767.805 or a substantially similar law of another state or
10 adjudicated to be the biological father. "Parent" does not include any person whose
11 parental rights have been terminated. For purposes of the application of s. 48.028
12 and the federal Indian Child Welfare Act, 25 USC 1901 to 1963, "parent" means a
13 biological parent, an Indian husband who has consented to the artificial
14 insemination of his wife under s. 891.40, or an Indian person who has lawfully
15 adopted an Indian child, including an adoption under tribal law or custom, and
16 includes, in the case of a nonmarital child who is not adopted or whose parents do
17 not subsequently intermarry under s. 767.803, a person conclusively determined
18 from genetic test results to be the father under s. 767.804, a person acknowledged
19 under s. 767.805, a substantially similar law of another state, or tribal law or custom
20 to be the biological father, or a person adjudicated to be the biological father, but does
21 not include any person whose parental rights have been terminated.
