**SENATE SUBSTITUTE AMENDMENT 1,  
TO SENATE BILL 163**

October 17, 2019 - Offered by Senator KOOYENGA.

1     **AN ACT** *to amend* 940.20 (7) (a) 1g. and 940.20 (7) (b); and *to create* 940.20 (2r)  
2             and 940.20 (7) (a) 4. of the statutes; **relating to:** battery to a health care  
3             provider who works at a hospital or a nurse and providing a penalty.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

4             **SECTION 1.** 940.20 (2r) of the statutes is created to read:

5             940.20 (2r) BATTERY TO A NURSE. (a) In this subsection, “nurse” means an  
6             individual who is licensed pursuant to s. 441.06 or 441.10.

7             (b) Whoever intentionally causes bodily harm to a nurse, or to an individual  
8             acting under the supervision of a nurse, who is acting in his or her professional  
9             capacity, and the actor knows or has reason to know that the victim is a nurse or an  
10            individual acting under the supervision of a nurse, by an act done without the  
11            consent of the individual so injured, is guilty of a Class H felony.
