I just wanted to confirm that you would like the amendment to also cover institutions of higher education. In Wisconsin, there are only two forms of public higher ed institutions – the UW System and the tech colleges. Everything else is private. So I will amend the definition of institution of higher ed on p. 1, line 6 to mean only the UW System and tech colleges if that is consistent with your intent. Can you confirm?

9 substitute “school board or operator”.

10 **4.** Page 3, line 17: delete the material beginning with “school board” and  
11 ending with “body” on line 18 and substitute “school board or operator”.
