Analysis by the Legislative Reference Bureau

This bill allows minors who are 12 and 13 years of age to provide caddy services without being employed by a golf course. Current law requires caddies who are 12 and 13 years of age to be employed by a golf course.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** 103.67 (2) (d) of the statutes is amended to read:
4 103.67 (2) (d) Minors 12 and 13 years of age may be employed as caddies on golf
5 courses, if they use provide caddy earts services.
6 **SECTION 2.** 103.79 (1) of the statutes is repealed.
7 **SECTION 3.** 103.79 (2) of the statutes is renumbered 103.79 and amended to

 5 shall be made as provided under s. 103.005. The orders are subject to review as
 6 provided in ch. 227.
