1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 12: before “The department shall” insert “When a complex needs
3 patient is in need of new complex rehabilitation technology, the patient shall obtain
4 prior authorization as set forth under this subsection.”.

5 **2.** Page 2, line 12: on lines 12 and 15, delete “physician” and substitute
6 “qualified health care professional”.
