Assumptions Used in Arriving at Fiscal Estimate

This bill recognizes same-sex marriage by utilizing gender neutral terminology in statutes.

The bill also recognizes legal parentage for same-sex couples under certain circumstances and adopts gender neutral parentage terminology.

Generally, the bill substitutes the term "spouse" for "husband" in the birth certificate statutes and enters the spouse, instead of the husband, of the person who has given birth on the birth certificate at times when a husband would currently be entered on a birth certificate.
