### **Assumptions Used in Arriving at Fiscal Estimate**

The bill updates state statutes to recognize same-sex marriage, recognizes legal parentage for same-sex couples under certain circumstances, and adopts gender neutral parentage terminology.

The bill would have little or no fiscal impact on the Department since the provisions have already been incorporated into policies and procedures for employee payroll and benefits practices.
