Assumptions Used in Arriving at Fiscal Estimate

The proposal does not stipulate the contents or physical characteristics of the special card WisDOT would issue. Assuming the department would utilize the same vendor contracted to produce identification and driver license cards, updates to our current systems would cost approximately \$156,225 in addition to an increase of \$35,000 for the design and production of the new card, resulting in a total IT cost of \$191,225. This is a one-time cost.

The department does not have any data to estimate the number of disabled motor bicycle operators this proposal would affect. The proposal does not provide for the department to charge for the issuance of these special cards. The department would incur ongoing costs of \$3 per card issued. Decals would need to be provided via from the department's central office at a cost of \$1.65 per mailing.
