**Assumptions Used in Arriving at Fiscal Estimate**

This bill limits a judge's discretion at sentencing and during post-sentencing proceedings by limiting the relief that can be granted to certain defendants and also limiting the defendants who may be eligible for the earned release program or the challenge incarceration program. Generally, the bill provides that the defendants to whom these limits would apply are defendants charged with certain violent crimes enumerated in the bill.

This bill does not create a new category of case to come before the circuit courts and will only impact cases already being brought. It also does not create new procedures that would require additional court hearings and resources. It is expected that existing court staff could absorb any changes that result from this bill.
