Assumptions Used in Arriving at Fiscal Estimate

This bill requires the Department of Agriculture, Trade and Consumer Protection (DATCP) to provide grant program funding to an organization that will use the funding to reimburse the costs of installing and purchasing farm tractor rollover protective structures that prevent injuries to the operating person caused by the overturning of a farm tractor. This bill creates appropriation 20.115(4)(fm) and provides \$250,000 GPR annually to allow DATCP to provide grants to an organization with the purpose of addressing human health and safety associated with rural and agricultural work, life, and environments. An organization that receives grant program funds is required to expend not less than seventy percent of the received grant money to reimburse the costs of installing and purchasing rollover protective structures for a farm tractor. Under the bill, the organization is required to pay seventy percent of the first \$1,670 of the cost of installing and purchasing a rollover protective structure for a tractor and one-hundred percent of the cost of installing and purchasing a roll-over protective structure that exceeds \$1,670.

If this bill is enacted, DATCP would incur additional costs to provide administration and program management of the allocated grant program funds to the determined organization.
