2019 ASSEMBLY BILL 261

June 7, 2019 – Introduced by Representatives QUINN, SARGENT, RODRIGUEZ, SHANKLAND, SORTWELL, SPIROS, SPREITZER, STUBBS and TUSLER, cosponsored by Senators PETROWSKI, BEWLEY and OLSEN. Referred to Committee on Education.

1 AN ACT to renumber and amend 101.128; and to create 101.128 (title) and 2 101.128 (2m) of the statutes; relating to: use of certain public building 3 restrooms.

Analysis by the Legislative Reference Bureau

This bill provides that, if the water closet compartments of a restroom in a building that is subject to the Commercial Building Code have full-height walls and doors, and the restroom's lavatories are located outside the water closet compartments, the restroom may be designated for use by both sexes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2	(b) (title) Restroom requirements Requirements.
3	2. 'Standards.' The department shall promulgate rules that establish
4	standards that the owner of a facility where the public congregates shall meet to
5	achieve the equal speed of access required under par. (a) <u>subd. 1</u> .
6	(c) 1. 'Exemptions established.' (intro.) This section subsection does not apply
7	to any of the following:
8	2. <i>Mixed-use facilities</i> . If a facility where the public congregates contains a
9	hotel, restaurant or school, the requirements of this section subsection shall apply
10	only to the portion of the facility where the public congregates that is not part of the
11	hotel, restaurant or school.
12	(d) 1. 'Six months after rules promulgated.' (intro.) This section subsection
13	applies to any facility where the public congregates at which the following events
14	begin on or after the first day of the 7th month beginning after the department
15	promulgates rules under this section <u>subsection</u> :
16	2. 'Renovations or additions.' In any existing facility where the public
17	congregates to which this section <u>subsection</u> applies under par. (a) 3. to 5. <u>subd. 1.</u>
18	<u>c. to e.</u> , the requirements of this section subsection apply only to the renovated
19	portion of the facility or to the structural or land addition of the facility.
20	SECTION 3. 101.128 (2m) of the statutes is created to read:
21	101.128 (2m) LAVATORY LOCATION. If the water closet compartments of a
22	restroom in a public building or place of employment have full-height walls and
23	full-height doors, and the lavatories in the restroom are located outside the water
24	closet compartments, the restroom may be designated for use by both sexes.
