ORDER OF THE PUBLIC SERVICE COMMISSION OF  
WISCONSIN ADOPTING AMENDED AND  
CREATED RULES

Section PSC 2.36 (as amended) and section PSC 2.80 (7) (as created), have been published in the February Notice Section of the Wisconsin Administrative Register. The Commission has received no petition for public hearing as provided for in section 227.02 (1) (e), Wisconsin Statutes.

ORDER OF THE PUBLIC SERVICE COMMISSION  
OF WISCONSIN  
Adopting and Amending Rules

Now, therefore, pursuant to authority vested in the Public Service Commission of Wisconsin by sections 194.34 (1), 196.36 and 227.08, Wis. Stats., the Public Service Commission of Wisconsin hereby orders that rules be amended and adopted as follows:

1. Section PSC 2.36 of the Wisconsin Administrative Code be and the same hereby is amended to read:

PSC 2.36 Transcripts. Proceedings in hearings will be transcribed and one copy furnished each party free of cost upon demand by such party at the hearing. Any party, within 5 days of the mailing of the transcript, may file with the commission a notice in writing of any claimed error therein, mailing a copy of such notice to each party of record. All parties will be advised by the commission of any authorized corrections to the record.

2. Section PSC 2.80 (7) of the Wisconsin Administrative Code be and the same hereby is adopted to read:

PSC 2.80 (7) When, as provided for in section 194.34 (1), Wis. Stats., a petition is made for a hearing on a grant or amendment of a contract carrier license made without hearing, the following requirements shall be met:

(a) A copy of the petition for hearing shall be forthwith served in the manner provided in section PSC 2.05 upon the person receiving the grant or amendment.

(b) The petition filed with the commission shall include a certification that a copy has been served as provided in (a).

(c) The petition for hearing shall state the facts showing the ground on which it is claimed that the petitioner is one having an interest within the meaning of section 194.34 (1), Wis. Stats.

3. The rule and amendment herein shall take effect on May 1 as provided in section 227.06 (1).

Further ordered, that certified copies of sections PSC 2.36 and PSC 2.80 (7), Wisconsin Administrative Code, as above amended and adopted be filed with the Revisor of Statutes and the Secretary of State as required by section 227.023, Wisconsin Statutes.
