ORDER OF THE WISCONSIN BOARD OF EXAMINERS IN OPTOMETRY AMENDING OPT. 9.01

Pursuant to authority vested in the Wisconsin Board of Examiners in Optometry by sec. 153.03 (4), Wis. Stats., said Board hereby amends section 9. 01 of the Wisconsin Administrative Code to read:

"Opt 9.01 Standards. The board shall consider unprofessional conduct any act which is stated or implied to be unprofessional in the statutes regulating the practice of optometry."

The amendment contained herein shall take effect on the 1st day of the month following its publication in the Wisconsin Administrative Register.
