ORDER OF THE STATE DEPARTMENT OF AGRICULTURE
ADOPTING AND AMENDING RULES

Pursuant to authority vested in the State Department of Agriculture by sections 93.07 (1) and 97.25 (2) (h) 2, Wis. Stats., the State Department of Agriculture hereby adopts and amends rules as follows:

SECTION 1. Sections Ag 51.02 (1) (a) and (c) of the Wisconsin administrative code are amended to read:

Ag 51.02 (1) (a) The following compounds are members of the class of dithiocarbamates: ferbam, maneb, sodium dimethyldithiocarbamate, thiram, ziram, zineb.

(c) The following compounds are members of the class of organic phosphates: S-(p-chlorophenylthio)-methyl 0,0-diethyl phosphorodithioate, 0,0-diethyl 0-(2-isopropyl-4-methyl-6-pyrimidinyl) phosphorothioate, 0,0-dimethyl S-(4-oxo-1,2,3-benzotriazinyl-3-methyl) phosphorodithioate, EPN, malathion, methyl parathion, parathion, systox (0,0-diethyl-(2-ethylmercaptoethyl) thiophosphate, a mixture of the thiono and thiol isomers).

SECTION 2. Section Ag 51.07 (4) of the Wisconsin administrative code is adopted to read:

Ag 51.07 (4) Chloropicrin is exempted from the requirement of a tolerance when used as a fumigant for the following grains: barley, buckwheat, corn, oats, rice, rye, wheat.

SECTION 3. Sections Ag 51.08 (1) (b) 2 and (c) 2 of the Wisconsin administrative code are amended to read:

Ag 51.08 (1) (b) 2. Vegetables: beets--garden (including tops), broccoli, brussels sprouts, cabbage, carrots, cauliflower, collards, cucumbers, endive (escarole), garlic, horseradish, kale, kohlrabi, leeks, lettuce, mustard greens, onions, parsnips, peanuts, radishes, rutabagas, salsify root, salsify tops, shallots, spinach, squash--summer, Swiss chard, turnips (including tops).

(c) 2. Vegetables: asparagus, beets--sugar (including tops), celery, eggplant, melons, peppers, pimentos, pumpkins, squash--winter, tomatoes.

SECTION 4. Sections Ag 51.08 (20) (a) 4 and 5 of the Wisconsin administrative code are amended to read:

Ag 51.08 (20) (a) 4. 30 p. p. m. for cucumbers, lettuce, peppers.

5. 50 p. p. m. for eggplant, summer squash, sweet corn, sweet potatoes, tomatoes.

SECTION 5. Section Ag 51.08 ⁽²⁰⁾~~(2)~~ (a) 6 of the Wisconsin administrative code is adopted to read:

Ag 51.08 (20) (a) 6. 75 p. p. m. for broccoli, carrots (including tops), melons, parsnips.

SECTION 6. Section Ag 51.08 (20) (c) of the Wisconsin administrative code is amended to read:

Ag 51.08 (20) (c) The tolerances for residues of inorganic bromides for the following commodities that have been fumigated with ethylene dibromide in accordance with the Mediterranean Fruit Fly Control Program or the Quarantine Program of the U. S. Department of Agriculture are:

1. 10 p. p. m. for beans (string), bitter melon (*Mormodica charantia*), cantaloups, Cavendish bananas, citrus fruits, cucumbers, guavas, litchi nuts, mangoes, papayas, peppers (bell), pineapples, Zucchini squash.

2. 20 p. p. m. for plums.

SECTION 7. Section Ag 51.08 (29) (e) of the Wisconsin administrative code is adopted to read:

Ag 51.08 ⁽²⁹⁾~~(20)~~ (e) Nuts: pecans, walnuts.

SECTION 8. Section Ag 51.08 (32) (f) of the Wisconsin administrative code is amended to read:

Ag 51.08 (32) (f) 200 p. p. m. for cottonseed and for the following nuts: almonds, Brazil nuts, bush nuts, butternuts, cashew nuts, chestnuts, filberts (hazelnuts), hickory nuts, peanuts, pecans, pistachio nuts, walnuts.

SECTION 9. Section Ag 51.08 (44) (b) of the Wisconsin administrative code is amended to read:

Ag 51.08 (44) (b) 10 p. p. m. for citrus fruits and pineapples.

SECTION 10. Section Ag 51.08 (44) (c) of the Wisconsin administrative code is adopted to read:

Ag 51.08 (44) (c) 20 p. p. m. for peaches.

SECTION 11. Section Ag 51.08 (46) (c) of the Wisconsin administrative code is amended to read:

Ag 51.08 (46) (c) 1.25 p. p. m. for grapes and hops.

SECTION 12. Section Ag 51.08 (50) (d) of the Wisconsin administrative code is adopted to read:

Ag 51.08 (50) (d) The fat of meat from cattle, goats and sheep.

SECTION 13. Section Ag 51.08 (51) (b) 2 of the Wisconsin administrative code is amended to read:

Ag 51.08 (51) (b) 2. Vegetables: beans, beets, black-eyed peas, broccoli, brussels sprouts, cabbage, carrots (including tops), cauliflower, celery, corn, cucumbers, eggplant, kohlrabi, melons, mushrooms, onions, parsley, peanuts, peas, peppers, pumpkins, radishes (including tops), rutabagas (including tops), salsify, squash, tomatoes, turnips (including tops).

SECTION 14. Section Ag 51.08 (51) (c) of the Wisconsin administrative code is renumbered Ag 51.08 (51) (d) and a new section Ag 51.08 (51) (c) is adopted to read:

Ag 51.08 (51) (c) 25 p. p. m. for the following vegetables: beet tops, Chinese cabbage, collards, endive (escarole), kale, lettuce, mustard greens, romaine, spinach, Swiss chard.

SECTION 15. Sections Ag 51.08 (57) (a) and (b) of the Wisconsin administrative code are amended to read:

Ag 51.08 (57) (a) 3 p. p. m. for grapes and pineapples.

(b) 5 p. p. m. for sugar beets and sugar beet tops.

SECTION 16. Sections Ag 51.08 (57) (c) and (d) of the Wisconsin administrative code are adopted to read:

Ag 51.08 (57) (c) 10 p. p. m. for potatoes.

(d) 35 p. p. m. for cottonseed.

SECTION 17. Sections Ag 51.08 (59), (60), (61), (62) and (63) of the Wisconsin administrative code are adopted to read:

Ag 51.08 (59) Dichlone (2,3,-dichloro-1,4-naphthoquinone). Tolerance is 3 p. p. m. for the following: apples, celery, peaches, tomatoes.

(60) 0,0-diethyl 0-(2-isopropyl-4-methyl-6-pyrimidinyl)-phosphorothioate. Tolerance is 0.75 p. p. m. for the following fruits: apples, cherries, pears.

(61) 0,0-dimethyl S-(4-oxo-1,2,3-benzotriazinyl-3-methyl) phosphorodithioate. The tolerances are:

(a) 0.5 p. p. m. for cottonseed.

(b) 2 p. p. m. for the following fruits: apples, crab-apples, apricots, nectarines, peaches, pears, quinces.

(62) Sodium dimethyldithiocarbamate, calculated as zinc ethylenebisdithiocarbamate. Tolerance is 25 p. p. m. for melons.

(63) S-(p-chlorophenylthio)-methyl 0,0-diethyl phosphorodithioate. Tolerance is 0.8 p. p. m. for the following fruits: apples, crabapples, pears, quinces.

SECTION 18. The rules and amendments contained herein shall take effect on March 1, 1958.
