ORDER OF THE PUBLIC SERVICE COMMISSION ADOPTING, AMENDING, AND REPEALING RULES

Pursuant to authority vested in the Public Service Commission by Chapter 194, Wis. Stats., the Commission hereby adopts, amends, and repeals rules as follows:

Sections PSC 50.02 (3), (4), (5), (7), (8), (9), (11), and (12) and PSC 50.03 (1) (c) 2. of the WISCONSIN ADMINISTRATIVE CODE are amended to read:

PSC 50.02 (3) HIGHWAY 16—Between its junction with highway 190 at Pewaukee and its intersection with highway 51 east of Portage.

- (4) HIGHWAY 18—Between Waukesha and its junction with highway 12 at Cambridge, except from Jefferson to its junction with highway 89 west of Jefferson.
- (5) HIGHWAY 24-Between its junction with highway 15 near East Troy and the Milwaukee County line.
- (7) HIGHWAY 32—Between the Illinois state line and the south Milwaukee County line.
- (8) HIGHWAY 36—Between Walworth and the Milwauke e County line except where it is coincidental with highway 83 between Burlington and Waterford.
- (9) HIGHWAY 45—Between the Illinois state line and the south Milwaukee County line and between its junction with highway 144 near Barton and its junction with highway 175 south of Oshkosh.
- (11) HIGHWAY 57—Between the Milwaukee County line and De Pere except where it is coincidental with highway 114 in Calumet County, except where it is coincidental with highway 10 in Calumet County, and except where it is coincidental with highway 32 in Manitowoc and Sheboygan Counties.
- (12) HIGHWAY 141-Between the Milwaukee County line and Green Bay except between its east junction with highway 42 and its north junction with highway 10 in Manitowoo County.
- PSC 50.03 (1) (c) 2. Fluid dairy products including whey;

Section PSC 50.02 (8a) of the WISCONSIN ADMINISTRATIVE CODE is repealed.

Section PSC 50.02 (13) of the WISCONSIN ADMINISTRATIVE CODE is adopted to read:

PSC 50.02 (13) HIGHWAY 175—Between the Milwaukee County line and its junction with highway hil south of Fond du Lac, except where it is coincidental with highway 28 north of Theresa.

The rules, amendments, and repeals contained herein shall take effect on April 1, 1959, as provided in section 227.026 (1), Wis. Stats.
