ORDER OF THE PUBLIC SERVICE COMMISSION REPEALING AND RECREATING RULES

Pursuant to authority vested in the Public Service Commission by Chapter 194, Wis. Stats., the Commission hereby repeals and recreates rules as follows:

Chapter PSC 34 of the WISCONSIN ADMINISTRATIVE CODE is repealed and created to read:

Chapter PSC 34

EXPANSION OF CONTRACT MOTOR CARRIER AUTHORITIES INVOLVING FARM HAULING

- PSC 34.01 <u>Transportation by livestock carriers</u>. Unless specifically restricted in the individual license, all contract motor carriers who are, or may hereafter be, authorized to transport livestock for the public in intrastate commerce from specified farm origin territories, shall be authorized in addition, to transport:
 - (1) Cattle, swine, sheep, goats, horses or mules, except those animals destined for direct slaughter purposes, between farms in such specified farm origin territory on the one hand, and any point within the state on the other hand, for farmers located in said farm origin territory, and
 - (2) Goods sold or offered for sale at auctions conducted for individual farmers, between farms in such specified farm origin territory on the one hand and any point within the state on the other hand, for farmers located in said farm origin territory.

PSC 34.02 Transportation by farm products carriers. Unless

specifically restricted in the individual license, all contract motor carriers who are or may hereafter be, authorized to transport, either specifically named farm products (excluding livestock, milk or cream) or farm products generally, for the public in intrastate commerce, from specified farm origin territories, shall be authorized in addition to transport:

- (1) Goods (except cattle, swine, sheep, goats, horses or mules) sold or offered for sale at auctions conducted for individual farmers, between farms in such specified farm origin territory on the one hand and any point within the state on the other hand, for farmers located in said farm origin territory.
- PSC 34.03 <u>Transportation by milk carriers</u>. Unless otherwise specifically restricted in the individual license, all contract motor carriers who are or may hereafter be, authorized to transport milk or cream from named farm origin territories to markets shall be authorized in addition to transport:
 - Supplies from the milk or cream receiving plant at destination to carrier's own patrons in said farm origin territories.

The repeal and recreation contained herein shall take effect on May 1, 1959 as provided in section 227.026, Wis. Stats.
