ORDER OF THE WISCONSIN STATE BOARD OF NURSING ADOPTING, AMENDING OR REPEALING RULES

Pursuant to authority vested in Wisconsin State Board of Nursing by Section 149.01(3) Wis. Stats., the board hereby repeals, amends and adopts rules as follows:

Section N 3.04 (1) (b) of the Wisconsin Administrative Code is amended to read:

N 3.04(1) (b) Instructor (known as resident teacher in a vocational school). The school shall demonstrate that it has an adequate number of nurse instructors for classroom teaching and hospital laboratory supervision each week throughout the entire program.

Section N 3.05 (2) of the Wisconsin Administrative Code is repealed.

Section N 3.08 (2) (c) of the Wisconsin Administrative Code is amended to read:
