ORDER ADOPTING AMENDED RULE

Notice of proposed amendment of section PSC 37.01 was published in the May Notice Section of the Wisconsin Administrative Register. The Commission has received no petition for public hearing as provided for in section 227.02 (1)(e), Wisconsin Statutes.

ORDER

NOW, THEREFORE, pursuant to authority vested in the Public Service Commission by Chapter 194, Wis. Stats., the Commission orders that said section PSC 37.01 be and the same hereby is amended to read as it appears in the following form to be filed with the Secretary of State and the Revisor of Statutes, as required by sections 227.023 and 227.024, Wis. Stats.:

ORDER OF THE PUBLIC SERVICE COMMISSION  
AMENDING A RULE

Pursuant to authority vested in the Public Service Commission by Chapter 194, Wis. Stats., the Commission hereby amends a rule as follows:

Section PSC 37.01 of the WISCONSIN ADMINISTRATIVE

CODE is amended to read:

PSC 37.01 Authorities to include named villages and cities. Each contract motor carrier license which authorizes operation for the public or for a contractor in: (1) the town of Greenfield shall be construed as including authority to perform a similar service in the villages of Greendale and Hales Corners and the city of Greenfield; (2) the town of Milwaukee as including authority to perform a similar service in the city of Glendale and the village of Bayside; (3) the town of Lake as including authority to perform a similar service in the city of St. Francis; (4) the town of Franklin as including authority to perform a similar service in the village of Greendale and the city of Franklin; (5) the town of Granville as including authority to perform a similar service in the village of Brown Deer and (6) the town of Oak Creek as including authority to perform a similar service in the city of Oak Creek, all in Milwaukee County unless the carrier notifies the Commission in writing that he elects not to accept such additional authority.

The amendment contained herein shall take effect on August 1, 1959, as provided in section 227.026, Wis. Stats.
