## ORDER OF THE STATE BOARD OF EXAMINERS IN CHIROPRACTIC ADOPTING AND AMENDING RULES

Pursuant to authority vested in the State Board of Examiners in Chiropractic by chapters 147 and 227 Wis. Stats., the agency hereby amends, and adopts rules as follows:

Sections 3.01 (2) of the WISCONSIN ADMINISTRATIVE CODE are amended to read:

Chir 3.01 (2) Dietary advice, and supplementary foods in the original container, may be supplied for the purpose of providing special dietary needs and improving nutritional balance, but such foods may not be prescribed as treatment for specific diseases.

Sections 3.02 (3) and 3.06 of the WISCONSIN ADMINISTRATIVE CODE are adopted to read:

Chir 3.02 (3) A chiropractor may employ a technician to operate an X-ray machine only upon furnishing proof satisfactory to the board that such technician has successfully completed a course of instruction approved by the board. Such work may be done only under the general supervision and direction of a licensed chiropractor.

Chir 3.06 The practice of chiropractic regularly in living quarters (bedside care excepted) as well as the maintenance of an unsanitary office or equipment shall be considered to be unprofessional conduct within the meaning of sec. 147.25, Wis. Stats.
