ORDER OF THE GROUP INSURANCE BOARD
ADOPTING, AMENDING AND REPEALING RULES

Pursuant to authority vested in the Group Insurance Board by section 66.919 (3) (a) Wis. Stats., and in conformity with section 227.02 (1) (b) Wis. Stats., the board hereby repeals, renumbers and adopts rules as follows solely to bring the language of sections Grp 2.02, 2.03 and 2.11 into conformity with Chapters 211 and 284 of the Laws of 1959 which changed the applicable statutory provisions subsequent to the adoption of such rules:

There is added to section Grp 2.02 of the WISCONSIN ADMINISTRATIVE CODE a paragraph (e) to subsection (1) thereof:

Grp 2.02 (1) (e) Prior to the end of the ensuing calendar month following the effective date of enactment, repeal, amendment or interpretation of any statute or rule, making any employe initially eligible for group life insurance. Coverage in such instances shall be effective as of the beginning of the next calendar month commencing after such waiver deadline.

Section Grp 2.03 of the WISCONSIN ADMINISTRATIVE CODE is repealed.

Section Grp 2.11 of the WISCONSIN ADMINISTRATIVE CODE is renumbered to be section Grp 2.20 of the WISCONSIN ADMINISTRATIVE CODE.

The rules adopted, repealed and renumbered contained herein shall take effect pursuant to authority granted by section 227.026 (1) Wis. Stats.
