GENERAL ORDER NO. 16

Pursuant to the authority vested in the Department of Securities by Chapter 189, Wisconsin Statutes, 1959,

IT IS HEREBY ORDERED that rules SEC 3.02, SEC 3.07, Chapter SEC 3 Form A and SEC 8.01 be amended as follows:

1. By deleting the words "State Office Building" in rule SEC 3.02 and inserting in lieu thereof the words "State Capitol."
2. By deleting the words "registered mail" in rule SEC 3.07 and inserting in lieu thereof the words "certified mail"; and by changing the address at the end of the rule from "325 State Office Building, 1 West Wilson Street" to "23 West, State Capitol."
3. By changing the address in Ch. SEC 3. Form A, Paragraph III, 1. from "Room 325, State Office Building, 1 West Wilson Street" to "23 West, State Capitol."
4. By changing the address in the preamble to rule SEC 8.01 from "325 State Office Building" to "23 West, State Capitol."

This order shall take effect upon filing a certified copy thereof with the Secretary of State and Revisor of Statutes in accordance with section 227.023, Wis. Statutes, 1959.


Some time ago our attorney discussed with your office several proposed amendments to the present rules of the department necessitated by the removal of our office from the State Office Building to the State Capitol. This matter has come to a head at this time for the reason that the department is in the process of reprinting its legal pamphlet and therefore desires to make the changes at this time although we have not as yet moved. However, the move will take place prior to the official publication of our pamphlet.

In addition to changing the address of the department in several of the rules, we have also changed the words "registered mail" to "certified mail" in accordance with the provisions of the statutes. These amendments, therefore, come within the purview of sec. 227.02 (1) (a) and (b), and require no hearing.

In accordance with your instructions we are also forwarding a certified copy to the Secretary of State in accordance with the provisions of sec. 227.02 (3) Stats.

A certified copy and an extra copy of our General Order No. 16 are enclosed.
