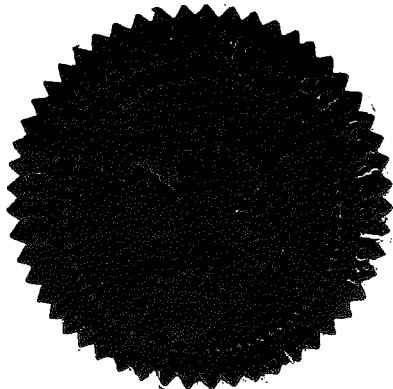

ORDER OF THE STATE CONSERVATION COMMISSION OF WISCONSIN AMENDING RULES

Pursuant to authority vested in the State Conservation Commission of Wisconsin by section 26.12, Wis. Stats., the State Conservation Commission of Wisconsin hereby amends rules as follows:

Section WCD 30.01 (2) (b) and (c) of the Wisconsin Administrative Code are amended to read:

WCD 30.01 (2)

(b) Burnett County

All lands outside of the limits of incorporated cities and villages in Burnett County except: Township 37 North, range 18 West; Township 38 north, range 18 west, south one half; Township 38 north, range 19 west, sections 23, 24, 25, 26, 35, and 36.

(c) Polk County

All lands outside of the limits of incorporated cities and villages in: Township 36 north, range 20 west; Township 36 north, range 19 west, sections 3, 4, 5, 6, 7, 8, 9, 10, 16, 17, 18, 19, 20, 21, 29, 30, 31, and 32; such portions of sections 15, 22, 28, and 33 lying west of what is commonly known as the Old St. Croix Falls Road, a public highway; Township 36 north, ranges 15 and 16 west lying north of State Trunk Highway 48; Township 36 north, range 17 west, sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15, 16, 21, 22, 23, and 24; and Township 37 north, ranges 15, 16, and 17 west.

The rules and amendments contained herein shall take effect on October 1, 1960.
