Pursuant to the authority vested in the Commissioner of the Motor Vehicle Department of the State of Wisconsin under Section 110.06, Wis. Stats., and after due notice and public hearing held February 12, 1962, as provided under Chapter 227, Wis. Stats., the Commissioner hereby repeals, creates and adopts the following rules:

IT IS HEREBY ORDERED, That Section MVD 10.06, Wisconsin Administrative Code, is hereby repealed.

IT IS FURTHER ORDERED, That Chapter MVD 15, entitled, "Fee Schedules for Searches and Certified Copies of Public Records,"

is hereby adopted as follows:

MVD 15.01 FEES FOR SEARCHES AND CERTIFICATES.

The following fees shall be charged for searches and certifications of department records as required by law when no statutory fee schedule is provided:

(1) <u>Searching Fee</u>. A fee of 35 cents shall be charged for each file searched, with a minimum fee of \$1.00.

(2) <u>Certified Copies</u> of <u>Notices</u>, <u>Records</u>, <u>Orders</u>, <u>Instruments</u> or <u>other Public Records</u>.

- (a) A fee of 50 cents per photostatic copy, with a certifying fee of \$1.00 shall be charged for any record. Any request for a photostatic copy without certification shall have a minimum fee of \$1.00.
- (b) A fee of \$1.50 per 8 1/2 x 11 double spaced page, with a \$1.50 certification fee shall be charged for typewritten copy.

(3) <u>Payment of Fees.</u> Sufficient payment to cover all searches or certifications must accompany each request. No searches or certifications will be made by the department if the request does not comply with this rule. No fee shall be required of law enforcement agencies or other state officials which are exempt by law. All out-of-state checks must be certified. Unless requested, no refunds shall be made by the department if the total amount to be refunded does not exceed 50 cents.
