ADOPTING A RULE

Notice of proposed creating of section PSC 113.115,  
Wisconsin Administrative Code, was published in the January  
1963 Notice Section of the Administrative Register. The  
Commission has received no petition for public hearing as  
provided for in section 227.02 (1) (e), Statutes.

Order

THE COMMISSION THEREFORE ORDERS:

Pursuant to authority vested in the Public Service  
Commission by sections 196.02 (1), (4) (a), 196.25, and  
227.014 (2) (a) (b), Wis. Stats., the Public Service Com-  
mission hereby adopts a rule of the Wisconsin Administrative  
Code to read as follows:

PSC 113.115 Forms to be filed. On or  
before May 1 of each year, all public  
utilities rendering electric service  
in Wisconsin who report to the Federal  
Power Commission on Form 12-12A or  
Form 12D shall supply a copy of such  
report to the Public Service Commission.

Section PSC 113.115, as herein created, shall take effect April 1, 1963, as provided in section 227.026 (1), Wis. Stats.
