ORDER OF THE STATE BANKING DEPARTMENT ADOPTING RULE

Pursuant to authority vested in the commissioner of banks by section 220.04 (6)(d), Wisconsin Statutes, Section Bkg 6.03 of the Wisconsin Administrative Code is adopted to read:

"Bkg 6.03 Investment in foreign bonds. Any state bank, trust company bank and mutual savings bank may invest in general obligation bonds issued by any foreign national government provided such bonds are payable in American funds, but at no time shall its aggregate investment in such foreign bonds exceed 3% of the capital and surplus of such bank. The provisions of this rule shall not apply to bonds and securities of the Canadian government and Canadian provinces, which are payable in American funds, the purchase of which is specifically authorized in Section 220.04 (6)(d), Wisconsin Statutes."

The rule contained herein shall take effect on September 1, 1964, as provided in section 227.026 (1).
