WCD 11.20 Closed area; public lands. A closed season is established in posted areas within the exterior limits of public hunting grounds, state wildlife areas, and other state-owned or leased lands administered for game management purposes, and it is unlawful for any person to take, catch, kill, hunt, trap, or pursue in any manner, any species of wild animals or birds on any such grounds, areas or lands so posted with conservation department signs.
