**ORDER OF THE  
PUBLIC SERVICE COMMISSION OF WISCONSIN  
ADOPTING RULES**

Pursuant to authority vested in the Public Service Commission by Chapters 196 and 227, Wis. Stats., the Public Service Commission hereby adopts Chapter PSC 168 of the Wisconsin administrative code to read:

**CHAPTER PSC 168**

**Telephone Rates and Charges**

**PSC 168.01 Charges for intrastate exchange telephone service to telephone utility employes and officers.** Permanent active telephone utility employes and officers may be billed for residence telephone service at charges of not less than 50% of those prescribed in the published schedules or tariffs applicable to the service.

**PSC 168.02 Intrastate toll service.** Intra-state toll service may be furnished to permanent active employes and officers at charges of not less than 50% of those prescribed in published schedules or tariffs applicable to the service.

**PSC 168.03 Schedules or tariffs to be filed.** No telephone public utility shall furnish any telephone service to its permanent active employes and officers at charges less than those prescribed in its published schedules or tariffs, as provided in these rules, unless and until the utility files a tariff with the Commission specifying the service provided those entitled to receive it and the amount of discount allowed.


PSC 168.04 Accounting for intrastate telephone service to employes and officers. Intrastate telephone service furnished to permanent active telephone utility employes and officers shall be priced at the full charges prescribed in the published schedules or tariffs and the aggregate amounts thereof credited to the appropriate revenue accounts. Any discount authorized by the provisions of sections PSC 168.01 to PSC 168.03, inclusive, shall be charged to operating expenses.

PSC 168.05 Termination of unauthorized discounts. Any telephone service being offered at a discount other than as specifically authorized by the provisions of sections PSC 168.01 to 168.04, inclusive, shall be billed at the full prescribed rate beginning with the first billing cycle 90 days from the effective date of said sections.

The created rules contained herein shall take effect on April 1, 1964 as provided in section 227.026(1), Wis. Stats.

Dear Sir:

There is enclosed a proper filing of created Chapter PSC 168 as adopted in Docket No. 2-U-5931, a copy of the February 28, 1964 order denying rehearing in said proceedings, and a copy for your files of a letter sent to the Secretary of State when we learned that Chapter PSC 168 had been filed at the time it was.

The Commission anticipates that the order and rules will be challenged in the Circuit Court for Dane County. This raises the question as to the effect thereof to stay the application of the rules or whether an application may be made in court to obtain a stay. There is also the possibility that the Legislature, when it reconvenes in April, may amend section 196.60, Statutes, under which the rules herein were promulgated.

We are releasing the attached page proof so that you may take such action as you see fit in regard to Chapter PSC 168 in the light of the forgoing situation. We would appreciate your advising us of your decision in this matter.
