ORDER OF THE GROUP INSURANCE BOARD AMENDING AND ADOPTING RULES

Pursuant to authority vested in the Group Insurance Board by section 66.919 (3)(a) Wis. Stats., and in conformity with Chapter 227 Wis. Stats., the board hereby amends and adopts rules as follows:

Rule Grp 2.20 (1) is amended to read as follows:

Grp 2.20 Amount of Insurance. (1) Except as provided under (2) the total salary or wages paid to an employe by the state during the previous calendar year pursuant to section 66.919 (μ)(e), Wis. Stats., shall be the total amount reported by the state for Wisconsin income tax purposes.

¹ Rule Grp 10.20 (1) is amended to read as follows:

Grp 10.20 Amount of Insurance. (1) Except as provided under (2) the total salary or wages paid to an employe by that municipality during the previous calendar year pursuant to section 66.919 (μ)(e), Wis. Stats., shall be the total amount reported by that municipality for Wisconsin income tax purposes.

Rule Grp 2.20 (3a) is created to read:

(3a) The provisions of rule Grp 2.20 (3), specifying that changes in amount of insurance shall be effective on January 1 in each calendar year if the amount is increased, are deferred for January, 1965 in those cases where the amendment in 1965 of rule Grp 2.20 (1) results in a different amount of insurance from that which would have otherwise applied, and increases in such cases shall be effective upon the date the amendment of rule Grp 2.20 (1) is effective.

A Rule Grp 10.20 (3a) is created to read:

(3a) The provisions of rule Grp 10.20 (3), specifying that changes in the amount of insurance shall be effective on January 1 in each calendar year if the amount is increased, are deferred for January, 1965 in those cases where the amendment in 1965 of rule Grp 10.20 (1) results in a different amount of insurance from that which would have otherwise applied, and increases in such cases shall be effective upon the date the amendment of rule Grp 10.20 (1) is effective.

Rule Grp 2.20 (4)(c) is amended to read:

(c) The amount of insurance which the insured employe elects to continue under the provisions of this subsection must have been determined originally from earnings reported for federal income tax purposes as shown on the form W-2 filed for the year on which such insurance coverage was based, or on the amount reported for Wisconsin income tax purposes, whichever applies as the result of the amendment in 1965 of rule Grp 2.20 (1). No election to continue insurance based on an estimate or projection of earnings may be considered valid.

The rules contained herein shall take effect pursuant to section 227.026 (1), Wis. Stats.
