## Order of the Department of Administration Adopting Rules

Pursuant to authority vested in the Department of Administration by sections 15.90 (2), as amended by ch 577, Supplement to Laws of Wisconsin for 1963, and 16.85 (5-a), Wis. Stats., the Department of Administration hereby adopts rules as follows:

Avm.  $A_{D,M}$ . Sections D.A. 1.01 through D.A. 1.06 of the Wisconsin Administrative Code are adopted to read:

> ADM. D.A. 1.01 Police officers ADM. D.A. 1.02 Designation of state office buildings ADM. D.A. 1.03 Motor Vehicle regulations ADM. D.A. 1.04 Parking ADM. D.A. 1.05 Allocation of parking spaces ADM. D.A. 1.06 Penalties

## ADM.

D.A. 1.01 Police officers. Such persons as shall be authorized by the Department of Administration shall be constituted Security Officers and shall have the power to enforce these rules and regulations, and for the purposes thereof shall police all property under the control of the Department of Administration. Such officers shall have all the powers provided in 15.90 (2) and section 16.85 (5-a), Wisconsin Statutes.

 $D_{\bullet}A_{\bullet}$  1.02 Designation of state office buildings. The following buildings are hereby designated as state office buildings for the purposes of parking regulation under these rules.

Category 1 - Parking regulated under section 15.90 (1), Wisconsin Statutes:

State Capitol Park and such portions of the curb on the Capitol Park side of the four surrounding streets as are designated in section 15.90 (1). Category 2 - Parking regulated under section 15.90 (2), Wisconsin Statutes:

Group A - State Office Buildings with established parking facilities:

Hill Farms State Office Bldg Eau Claire District State Office Bldg La Crosse District State Office Bldg Wisconsin Rapids District State Office Bldg

Group B - State Office Buildings with limited parking facilities:

Wilson Street State Office Bldg Milwaukee District State Office Bldg

D.A. 1.03 Motor vehicle regulations.

ADM.

(1) (a) No person not holding a valid and current operator's license issued under chapter 343, Wis. Stats., shall operate any motor vehicle on any roadway under the control of the Department of Administration unless exempt under the provisions of section 343.05, Wis. Stats., from the requirement that he hold such a license in order to operate a motor vehicle on the highways of this state.

(b) No person shall operate any motor vehicle on any roadway under the control of the Department of Administration unless the same has been properly registered as provided by chapter 341, Wis. Stats., unless exempt under the provisions of section 341.05, Wis. Stats., from the requirement that the vehicle be registered in order that it may be operated on the highways of this state.

(2) All provisions of chapter 346, Wis. Stats., entitled "Rules of the Road" which are applicable to highways as defined in section 340.01 (22), Wis. Stats., are hereby adopted for the regulation of traffic on the roadways under the control of the Department of Administration except as follows:

- (a) Provisions of chapter 346, Wis. Stats., which are in conflict
- with any specific provision of these regulations.
- (b) Penalty provisions of chapter 346, Wis. Stats.
- (c) Sections 346.61 through 346.74, Wis. Stats.

(3) If any provision of this regulation is invalid, or if the application thereof to any person or circumstance is invalid, such invalidity shall not affect other provisions or applications which can be given effect without the invalid provision or application.

## ADM. D.A. 1.04 Parking.

(1) Parking on the grounds of the several state office buildings is regulated by means of appropriate signs and other visual indications (painted curbs, etc.).

(2) Stopping and parking on the grounds of the several state office buildings is prohibited in certain specified places as provided by section 346.52 and section 346.53, Wis. Stats.

HDAN, 1.05 Allocation of parking spaces.

(1) The Department of Administration shall allocate available space at Category 2-A locations (see 1.02 above) in the following priority:

- 1. Accommodation for fire, police, and other emergency vehicles, taxicabs, and service vehicles.
- 2. Accommodation for disabled persons, employees or public. In the case of employees, disability shall be established by written statement and physician's verification if requested.
- 3. Accommodation of public transacting business with tenant departments.
- 4. Provision for parking of staff cars, a staff car being defined as a state owned and licensed vehicle.
- 5. Parking for employees of tenant agencies as allocated by the Department of Administration.

(2) The Department of Administration shall allocate available space at Category 2-B locations (see 1.02 above) in the following priority:

- 1. Accommodation for fire, police, and other emergency vehicles, and for service vehicles.
- 2. Provisions for parking of staff cars by permit only.
- 3. Parking for employees of tenant agencies by permit only as allocated by the Department of Administration.

(3) Parking shall be restricted at Category 1 locations (see 1.02 above) as provided in section 15.90 (3), Wis. Stats. Apra.

D.A. 1.06 Penalties. The penalties for violating these rules and regulations are those set forth in section 15.90 (2), Wis. Stats.

The rules contained herein shall take effect on December 1, 1965, pursuant to authority granted by s.227.026 (1)(b).
