

RULE CHAPTER MVD 16 OF THE WISCONSIN ADMIN- \* ORDER ADOPTING EMERGENCY RULE  
ISTRATIVE CODE, RELATING TO THE USAGE OF \* UNDER 227.02 (1)(e), WIS. STATS.,  
STUDDED TIRES UNDER 347.45 (2)(c) 1 and 4, \* AND 227.027, WIS. STATS., WITHOUT  
WIS. STATS., AS AMENDED BY CHAPTER 315 OF \* NOTICE AND PUBLIC HEARING

Pursuant to authority vested in the State of Wisconsin Motor Vehicle Department under 347.45 (2)(c) 1 and 4, Wis. Stats., as amended by Chapter 315 of the Laws of 1965, the Commissioner of said department hereby adopts rules as follows:

Chapter MVD 16 of the Wisconsin Administrative Code is hereby adopted to read:


Chapter MVD 16 - Studded tires. [347.45 (2)(c) 1 and 4, Wis. Stats., as amended by Chapter 315 of the Laws of 1965] Tungsten carbide studded tires may be used on vehicles specified in this subsection annually from the fifteenth day of October each year to the fifteenth day of April.

Studded tires for heavier vehicles or not specifically covered by Statute, may be used for study only after written approval of the Commissioner of usage in accordance with the purpose of this subsection.

This rule contained herein shall take effect immediately on publication in the official state paper as provided in 227.027, Wis. Stats., and shall remain in effect as an emergency rule until the adoption of a permanent rule in accordance with 227.02 (1)(e), Wis. Stats.; or, until the expiration of the period of 120 days, whichever is the lesser. Facts constituting the emergency rule are as follows:

Chapter 315 of the Laws of 1965 provides for the usage of studded tungsten carbide tires to be used on our highways for the safety of the motoring public on icy and snowy conditions of the highways during the fall, winter and spring months; and, further, experimental usage of other type tires for the same purpose and on other type vehicles, may be authorized by the said Motor Vehicle Department. Snowy and icy conditions may occur any day or night in the immediate future, requiring immediate usage of such tires by those who elect to purchase and install them on their motor vehicles.
