



ORDER OF THE STATE CONSERVATION COMMISSION OF WISCONSIN

ADOPTING, AMENDING AND REPEALING RULES

Pursuant to authority vested in the State Conservation Commission of Wisconsin by section 27.01 (2), Wis. Stats., the State Conservation Commission of Wisconsin hereby repeals, amends, and adopts rules as follows:

WCD 41.02 of the Wisconsin Administrative Code is created to read:

WCD 41.02 Rock Island State Park. All state-owned lands now or that hereafter may come under the jurisdiction of the state conservation commission, located within the following areas, are established and designated as the Rock Island State Park:
