ORDER OF THE  
PUBLIC SERVICE COMMISSION OF WISCONSIN  
ADOPTING, AMENDING OR REPEALING RULES

Pursuant to authority vested in the Public Service Commission by chapter 194, Wis. Stats., the Public Service Commission hereby amends, adopts, and repeals rules as follows:

Section PSC 50.02 (Introductory Paragraph) of the Wisconsin Administrative Code is amended to read:

PSC 50.02 (Introductory Paragraph) Restricted highways. No such motor carrier shall, except by special permission of the commission, operate any motor vehicle of more than 8,000 pounds total weight between the hours of 1:00 P.M. and 10:00 P.M. on Saturdays or between the hours of 9:00 A.M. and 10:00 P.M. on Sundays or legal holidays, except as otherwise provided by subsection (1a) hereof, from May 28 to the second Sunday in September, both inclusive, upon any of the following highways, including highways which may coincide with said highways unless specifically exempted herein, described in accordance with the numbering on the current official highway map, except at intersections of such described highways with highways not included in this chapter, and except within the corporate limits of cities and villages.

Section PSC 50.02 (1), Wisconsin Administrative Code, is amended to read:

PSC 50.02 (1) HIGHWAY 12--Between Lake Geneva and its junction with highway I-90--I-94 at Rocky Arbor, except where it is coincidental with high-

way 15 north of Elkhorn, except where it is coincidental with highway 73 west of Cambridge, except from its intersection with highway I-90 east of Madison westerly to its junction with highway 14 at Middleton, and except where it is coincidental with highway 33 north of Baraboo.

Section PSC 50.02 (1a) of the Wisconsin Administrative Code is created to read:

PSC 50.02 (1a) HIGHWAY 12--Between its junction with highway I-94 north of Tomah and its junction with highway 53 near Eau Claire, except where it is coincidental with highway 27 near Black River Falls and near Augusta, and except where it is coincidental with highway 10 near Fairchild; and the restriction on said designated segment of highway 12 shall apply between the hours of 9:00 A.M. and 10:00 P.M. on Saturdays, Sundays, and legal holidays.

Section PSC 50.02 (3) of the Wisconsin Administrative Code is amended to read:

PSC 50.02 (3) HIGHWAY 16--Between its junction with highway 190 at Pewaukee and its junction with highway 19 east of Watertown.

Section PSC 50.02 (6) of the Wisconsin Administrative Code is repealed.

Section PSC 50.02 (10) of the Wisconsin Administrative Code is amended to read:

PSC 50.02 (10) HIGHWAY 50--Between highway 41 and Delavan except where it is coincidental with highway 12 east of Lake Geneva.


Section PSC 50.02 (11a) of the Wisconsin Administrative Code is created to read:

PSC 50.02 (11a) HIGHWAY 120--Between the  
Illinois state line and Lake Geneva.

The rules, amendments, and repeals contained herein  
shall take effect on May 1, 1967 as provided in section  
227.026, Wis. Stats.
